#### 1 VISION AND MISSION

#### 1.1 Vision

**Euro-Mediterranean University** (EMUNI), headquartered in Slovenia, will significantly contribute to the development of Higher Education and Research Area and to sustainable development of wider social-economic and cultural environment in the EUROMED countries<sup>1</sup>, as well as to the recognition of Slovenia in the Euro-Mediterranean region.

#### 1.2 Mission

**EMUNI** is an international association of universities with headquarters in Slovenia. It represents one of the six projects of the Union for the Mediterranean, approved in the frame of a common declaration, adopted in Paris on 13 July 2008. Within the mission of EMUNI, the following goals shall be achieved:

- Raising quality of higher education through the implementation of study and research programmes;
- Becoming an international university, which will acknowledge cultural diversity;
- Establishing university environment, which will have a stimulating effect on the integration of different nations and cultures in the academic spheres;
- Ensuring administrative, operational and material infrastructure, which will enable the operation of the university.

The goal of EMUNI is to create specialised study programmes among the Euro-Mediterranean universities. The study programmes will cover themes and areas, which are significant for the Euro-Mediterranean area. The study programmes or parts of them will be implemented at EMUNI as well as other universities, co-founders of EMUNI.

One of the main activities of EMUNI is also research, which is one of the important factors of development, success and quality of the University.

The basic mission of the University is to contribute with its higher education activities to strengthening intercultural dialogue in the Euro-Mediterranean region and to contribute to the priority goals of the Barcelona process, which is in the broader sense included also in the Union for the Mediterranean.

#### 1.3 EMUNI Development Strategy 2014-2018

EMUNI has proposed the Strategy of EMUNI for 2014-2018. Discussions about EMUNI development strategy have often been held during sessions of EMUNI bodies. EMUNI has strengthened its basis for the development of the strategy in 2013 with self-evaluation reports and discussions during sessions of EMUNI bodies.

EMUNI Management Board adopted the Strategy of EMUNI for 2014-2018 at its 25<sup>th</sup> session on 21 February 2014. In accordance with the strategy and the work programme, EMUNI will pursue and implement its goals.

Since its establishment in 2008, EMUNI, one of the priority projects of the Union for the Mediterranean, has become an international institution, which gathers expert knowledge and experience of the Euro-Mediterranean countries and thus contributes in a significant way to the creation of a unified, integrated Euro-Mediterranean higher education and research area.

University to a large extent conducts its operation at its seat in Portorož, where the spatial conditions for some of its activities are fulfilled. When additional premises are needed, they are rented at the academic institutions in the surroundings.

EMUNI can implement the study activity of all study areas, classified in accordance with the international classification Isced (UNESCO, 1997). EMUNI organizes the implementation of study programmes, which are accredited at the partner universities in Slovenia and other partner countries of EMUNI. The University conducts research activities at all scientific fields of research, classified in accordance with the international classification Frascati (UNESCO, 2002).

#### Important dates:

- February 2009: entry into the court register;
- June 2009: accreditation of the first study programme at EMUNI, which has already been accredited at the University of Maribor;
- July 2009: EMUNI is entered into the Register of Higher Education Institutions in the Republic of Slovenia (hereinafter referred as "Register");
- December 2009: EMUNI obtains the Erasmus University Charter;
- July 2011: two master study programmes ("Business Communication in the International Environment" and "Environment Analyses and Management") are entered into the Register at the Ministry, competent for higher education;
- Changed the seat of the University from Portorož to Piran, Slovenia.



#### 3 LEGAL BASIS AND GOALS

# Legislation

EMUNI is an international association of universities, established by means of EMUNI Memorandum of Association in conformity with the Foundation Charter of EMUNI University and pursuant to the Act Amending the Higher Education Act (Official Gazette of RS, no. 64/08).

The EMUNI University is an international association of universities with the seat in Slovenia, organised as a Slovenian legal entity, registered as a higher education private institution. Being registered in Slovenia, it is primarily governed by Slovenian law. Signatories of the agreement and other members of the General Assembly may exercise the founders' rights in the University in accordance with the Statute of the University.

# 4 Academic year 2016/2017

#### 4.1 Master study programme Intercultural Business Communication

#### Enrolment

Four students of the six were enrolled in the 2nd year of the programme as two students withdrew. The call for enrolment in the 1st year was published, but with no successful enrolment of two candidates from Syria.

#### Course delivery

The face-to-face sessions of the 2<sup>nd</sup> year started in November 2016 with the following courses conducted: English Language II, French Language II, Internet Marketing, Internationalization Strategies and Information Technology Abilities for Business.

Except for both languages that continued with face-to-face sessions in March 2017, the rest of the courses was concluded on-line by then. During the second face-to-face session the Research Methodology and Master Thesis course was introduced, which is not part of the curriculum, but reasonably assisted students in delivering their Master Thesis Proposals until the summer. All three proposals were approved by the Commission for Student and Study Affairs by the end of the academic year, allowing students to continue their work towards graduation.

#### Collaboration activities

EMUNI joined a network of Universities conducting Master Programmes on Intercultural Communication, named EUROCAMPUS. The Master programmes are conducted in several Universities around Europe, each year a different university in the network hosts one semester in the fall. Starting September to December 2017, EMUNI participated with one student and one lecturer conducting the course of Socio-Economic Processes in the Mediterranean. This participation should allow a double degree diploma with the University of Urbino to the EMUNI student.

# 4.2 Professional upgrading study programme Euro-Mediterranean Innovation and Entrepreneurship

#### **Enrolment**

In the academic year 2016/2017, EMUNI launched a 12-month, non-degree programme on Innovation and Entrepreneurship. This diploma is a Professional Upgrading Certificate. The application period opened in June 2016. We received 74 applications, from which 50 students were invited for personal interviews. Finally, 26 students were selected and enrolled. The students are coming from Egypt, Palestine, Morocco, Algeria, Tunisia and Ghana.

#### Course delivery

Between 24 October and 18 November 2016, they attended the face-to-face lectures in Piran, Slovenia and Siena, Italy with the following courses conducted: Introduction to Entrepreneurship and Entrepreneurship Opportunity Recognition, Field Visits ½, Human Resource Management and Entrepreneurial Business and Governance Models. The lecturers came from Slovenia, Italy and Morocco. In the beginning of 2017 the programme continued with on-line and face-to-face classes in Egypt and Morocco provided for the Modules in Finance, Project Management and Legal Environment, in partnership with Arab Academy and their respected lecturers. In May 2017 students came to Slovenia for the face-to-face module in Entrepreneurial Marketing Strategies provided by a visiting professor

from Great Britain and in the frame of Field Visits 2/2 attended the Business Conference (BIZBarcelona) in Spain.

#### Collaboration activities

EMUNI received 18 full scholarships for the Egyptian students from the Al Alfi Foundation in Egypt, and some participating Universities from Italy and Morocco as well as EMUNI provided partial or complete scholarships for other students.

## 4.3 Summer School on Euro-Mediterranean Studies – Migration and the Euro-Mediterranean Region

EMUNI Summer School was conducted as a Jean-Monnet Module between 19 and 23 June in a distance learning format and between 26 and 30 June 2017 in a face-to-face format. In total 26 were accepted and confirmed their participation and 18 participants from 13 different countries (Turkey, Lithuania, Slovenia, Italy, Hungary, Brazil, Algeria, Belgium, South Korea, Egypt, Pakistan, Tunisia and Switzerland) made it to the summer school. 12 professionals from the field contributed to the successful deliverance of the courses and field trips.

# 5 Academic year 2017/2018

# 5.1 Master study programme Intercultural Business Communication

#### **Enrolment**

In March 2017, the application period for the enrolment into the 1<sup>st</sup> year of the academic year 2017/2018 was opened. There were 9 new applications and 5 students (coming from Egypt, Tunisia, Algeria, Macedonia and Syria) were enrolled. Later, one of these students decided not to continue with the studies and withdrew. The online classes of five courses (History of Socio-Economic Global Processes, Intercultural Laboratories, International Business Communication, English Language I and a newly introduced course Italian Language started in November 2017. There was a face-to-face period between 20 November and 22 December 2017, which was joined by three students (the fourth one did not get the visa and was following lectures online).

All the four students already enrolled are proceeding with their studies in the final graduation year of the programme, three of them are already working on finalizing their master thesis. Regarding the call for enrolment in the 1st year, EMUNI received 9 applications, of which 7 were eligible to enrol, and finally 5 new students successfully enrolled in the 1st year of the IBC programme, coming from 5 different countries (Syria, Tunisia, Algeria, Macedonia and Egypt). All the 5 accepted students conditioned their enrolment with an offer of a full scholarship and EMUNI offered to cover full tuition fees to them all, as well as accommodation cost for the duration of face-to-face sessions. Handiling of travel costs will be managed on a case by case basis and opportunities for co-financing them. EMUNI has supported 4 of the accepted students in the visa procedure, one of which is particularly complex situation (Syrian student living in Syria).

#### Course delivery

The first face-to-face session of newly enrolled students has started on 20 November and was concluded by 22 December 2017 with the following courses: English Language I, Italian Language I, Academic Writing Skills and Basic Research, Intercultural Laboratories — Practical Training, History of the Global Socio-Economic Processes and Intercultural Business Communication. The study programme with its courses is delivered in a combined method of on-line and face-to-face education.

#### Collaboration activities

With the end of the 2016/2017 academic year, EMUNI joined the EUROCAMPUS initiative. The Eurocampus was conducted at the University of Urbino between October and December 2017. EMUNI participated with one student and one lecturer conducting the course of Socio-Economic Processes in the Mediterranean. The student successfully completed the whole semester by December 2017, thus, became eligible for the double degree diploma with the University of Urbino, Italy.

In April 2017 the Senate adopted the Call for Enrolment for the professional upgrading study programme Euro-Mediterranean Innovation and Entrepreneurship Certificate (50 ECTS) for the academic year 2017/2018. The deadline for application was set on 8 September 2017 and was extended to 15 February 2018.

# 5.2 Professional upgrading study programme Euro-Mediterranean Innovation and Entrepreneurship

#### **Enrolment**

The application period for the Innovation and Entrepreneurship Diploma was open until the end of the calendar year 2017. The actual enrolments were foreseen for January 2018. The already enrolled students are to graduate with their final assignment by the end of the academic year 2017/2018.

#### Course delivery

A final Module involving the official graduation of previously enrolled students is planned in spring 2018. The programme for the 2017/2018 will be defined based on the enrolled students and their profiles and interests, involving partner institutions.

# 5.3 Blue Mission – Training Course

Between 13 and 17 November 2017, a professional training course for young professionals on blue growth in the Mediterranean has been organised. The training was co/financed by the Ministry of Foreign Affairs and Ministry of Environment and Spatial Planning. The objective of the training is to enhance the knowledge and capacity of young professionals on the concept and applications of blue growth initiatives in the Mediterranean Sea basin with a view to contributing to the creation of new and qualified "jobs of the sea". The course is designed in part as a general introduction to the issue of ocean economy and blue growth, and in part as an investigation of the potential in that context of the specific sector of maritime transport. 23 individuals under age of 35 participated in the course, which included a rich programme of expert sessions and study visits.

# 5.4 Cooperation in the development of a new master programme AdapTM

Since 2017 EMUNI will be participating in designing and implementing an interdisciplinary master's degree study programme titled Smart Environment and Climate Change Management. The master contributes towards sustainable developement and is based on building capacity in the field of emerging technologies in environment change management in a competence-based education system, in line with the Bologna process. The development of a programme is a result of a successfully gained 3-year Erasmus+ project in a consortium of participating universities.

## Erasmus+ programmes

By the end 2017 EMUNI has signed 13 new Erasmus+ bilateral agreements with higher education institutions from partner countries. Bilateral agreements are the basis for the participation in the programme Erasmus+ programmes and enable participation in projects, student exchange, staff mobility and other activities, related to upgrading the university curricula. In November 2017, EMUNI hosted teaching (1) and administrative staff (2) from two partner universities in Egypt: Arab Academy for Science, Technology and Maritime Transport.

#### Application of the Jean Monnet Module

In 2017 EMUNI did not apply a project within Jean Monnet Module (Erasmus+ programme). We dediced not to apply, since we are implementing the current one with title "Euro-Mediterranean Studies - Current and Future Perspectives.

#### Application of the Jean Monnet Project

In 2017 EMUNI applied with a new project proposal within Jean Monnet Project (Erasmus+ programme) under the title "MED-HUB: Establishing EMUNI Knowledge Hub on Euro-Mediterranean Studies" but the proposal was not granted by the funding agency, but the application package serves as a basis for future similar calls (2018).

### 5.5 Application of the individual mobility

In 2017 EMUNI applied for an Erasmus+ KA107 project (staff mobility with Southern Mediterranean Countries) in a consortium with University of Maribor and University of Primorska. We were granted in total, as a Consortium, 79 mobilities (incoming and outgoing) with Algeria, Egypt, Israel, Jordan, Lebanon, Morocco and Tunisia. The aim of these mobilities is to enhance the inter-institutional cooperation through staff mobility and to empower staff with intercultural experience.

#### 5.6 Events where EMUNI is a (co)organiser

EMUNI Conferences offer a valuable platform for networking, exchange of expertise between participants and the opportunity to acquire new skills in selected areas. They also aim at disseminating research results.

# **EMUNI Annual Conference**

EMUNI Annual Conference took place on Wednesday and Thursday, 5th-6th April, in Piran (Slovenia). EMUNI's event, together with its General Assembly, the brainstorming meeting held by MERID (Horizon2020 project funded by the EU) and a stakeholder forum under the Horizon 2020-funded 4PRIMA project, addressed the topics of Youth, Employability and Entrepreneurship: The Role Of Higher Education Institutions. This conference capitalised on achievements by the EMUNI University – notably the recently launched Upgrading Diploma on Entrepreneurship & Innovation – as well as on the UfM Med4Jobs Initiative and the conclusions of the II UfM Regional Forum Mediterranean in Action: Youth for Stability and Development (Spain, 23–24 January 2017), where UfM Foreign Affairs Ministers endorsed the UfM roadmap.

Building on the conclusions of the UfM Ministerial Conference on Employment and Labour (Jordan, 26-27 September 2016) and in view of the Ministerial Conference on Strengthening Euro-Mediterranean Cooperation through Research and Innovation (Malta, 3-4 May 2017), this conference provided a unique platform for structuring regional collaboration gathering policy-makers, representatives of academia,

business sector and youth to come up with solid recommendations that could develop into concrete actions.

# Implementation of the MERID project

In 2014, EMUNI was granted a 999.750 EUR project within the Horizon 2020 programme of the European Union with the title Middle East Research and Innovation Dialogue (MERID). Project proposes a comprehensive action to intensify and encourage research and innovation cooperation between the EU and the Middle East region, directly involving partners from Egypt, Iran, Iraq, Jordan, Lebanon and Palestine. The project is the first attempt to systematise support to the policy dialogue and involvement of research communities of Iran and Iraq in the H2020 programme, as well as an initiative that seeks to give continuity to collaboration frameworks already established between the EU and Middle East countries.

In 2017, EMUNI organized the following events:

- MERID Brainstorming meeting for recommendations for an enhanced EU-Middle East STI Cooperation organised by EMUNI on 5 April 2017 in Piran, Slovenia.
- MERID Project (Middle East Research and Innovation Dialogue) workshop at the EU-Iran Higher Education and Research event held by the European Commission on 3 July in Tehran, which also required remote support from EMUNI in terms of organisation.

#### Implementation of MEDNICE project

In 2016, EMUNI was granted a new project called MEDNICE under the Interreg MED Programme. MEDNICE is one of the three Horizontal Projects approved for coordinating ten Modular Projects (MPs) under priority axis Energy Efficient Buildings. EMUNI's key role in the project is to ensure networking and community building between the different MPs and other stakeholders.

As a MED hub for Energy Efficiency (EE) innovative and shared solutions, the MEDNICE project will anchor a MED community around energy issues that public organisations face in order to promote modular projects' results and increase their impact on public policies. Indeed, in the MED area, the majority of public buildings is not adequately designed to reduce their energy consumption and improve their EE performance. This is partly due to a lack of awareness of owners and managers and knowledge gaps regarding common answers to this transnational challenge. Thus, the overall objective of MEDNICE is to empower MED projects' partners through the establishment of a MED community and a joint transnational framework around energy efficiency in public buildings. By setting up training and peer learning mechanisms, MEDNICE will contribute to increase the capacity of owners and managers of public buildings to design and implement better energy efficiency practices. It will set up a knowledge platform that will allow for capitalizing and communicating results and outputs of the modular projects. It will serve as a cornerstone of a transnational peer network laying the ground for a MED identity. MEDNICE will also analyze and summarize EE practices through thematic and policy papers to be promoted and benefit the MED community. Relying on Ambassadors this will help disseminate and

transfer messages in order to advocate for specific MED EE policies and mainstream them in relevant strategies.

The overall objective of the project is to empower MED projects' partners through the establishment of a MED community and a joint transnational framework around energy efficiency in public buildings. The project will set up a platform that will allow for transferring outputs deriving from the modular projects. The transnational peer network to be created by the project will facilitate peer-to-peer exchanges and joint learning through virtual and face-to-face meetings. By relying on a strong MED community, empowered public stakeholders will have the means to review their policies and investments needed to optimize energy planning measures and management to ultimately reduce

In 2017, one major event took place in the frame of MEDNICE project where EMUNI was one of the main organisers:

- First Annual Congress gathering representatives of 10 Modular Projects addressing energy efficiency related issues in public buildings and other stakeholders such as Mr. Dominique Ristori, Director General for Energy of the EU Commission, Mr. Julien Guerrier, Director of EASME, Mr. Pierre-Emmanuel Noel, Senior Banker at EIB and Mr. Jorge Borrego, Deputy General Secretary of the UfM. The event was held on 4-6 October 2017 in Nice, France.

# Implementation of ERC project

ERC = Science2, funded by the European Research Council (ERC) and coordinated by Science | Business, is a communication project aimed at broadening the ERC's popular and political support as widely as possible across Europe. ERC = Science2 will in the coming 42 months talk about the science done in the framework of ERC grants and their cutting-edge variety that can capture the imagination, change the world and stimulate curiosity. To this end, the consortium will launch a novel communications campaign, including catchy contents and easy to understand examples of cutting edge research findings, that will be promoted and distributed across an unusually broad network of science and natural history museums, zoos and aquaria, universities and research organisations in Europe. Activities will involve innovative approaches for communicating science to children and teenagers through provoking and entertaining formats, as well as events tailored to reach out to young academics and researchers, such as science cafés, brown-bag lunches, and research speed-dating. During the lifespan of the project, more than 75 events were planned in many different countries and languages.

EMUNI's role in the project consists of organisation and implementation of outreach events on campuses in Slovenia, Austria, Hungary, Greece, Serbia, Montenegro and Macedonia. In the framework of the project, a lecture took place with the Slovenian ERC Grantee Jernej Ule in Ljubljana on 30 August 2017.

# 5.7 Seminars, workshops, lectures and related activities

2017 very was active in terms of cooperation at different activities, e. g. conferences and round tables. EMUNI cooperated in following activities:

- 9. The event was held by the UfM at the Headquarters of the UfM Secretariat in Barcelona (ES).

#### 5.8 Other international activites

Due to its establishment and operation, EMUNI is embedded in the broad international institutional framework. This brings with it obligations to participate in the mandatory meetings, conferences and other international events, directly related to the areas of work and research of EMUNI.

## Missions

#### Missions to Euro-Mediterranean institutions

EMUNI was established as one of the six key initiatives of the Union for the Mediterranean to cover the higher education and research. It is important to keep good and productive relations with Euro-Mediterranean institutions, since EMUNI is discussing and pursuing their agenda as well. Therefore, we expect many missions and meetings with representatives of different institutions (e. g. Union for the Mediterranean, Mediterranean Citizens' Assembly Foundation, EMUNI partners and relevant stakeholders, EuroMeSCo, IEMed etc.).

#### Missions to EU institutions

EMUNI was granted 6 very important European projects and is thus coordinating very much with the EU institutions. Moreover, since EMUNI also represents Euro-Mediterranean platform, it is an important speaker for EU institutions. At least ten (10) missions and meetings are foreseen in 2017 with the representatives of the EU institutions.

#### Missions to National institutions

Attempting to act as a promotor of Slovenia in the Euro-Med region, and in view of indeed cooperating on the implementation of the Slovenian foreign policy agenda (in the Positive Agenda for Youth initiative) EMUNI needs to be in contact with the national environment. To maintain these connections missions are essential for building relationships.

#### Missions to other Mediterranean countries

EMUNI has more than 128-member institutions from 32 (Euro-)Mediterranean countries. It is a hub of ideas between the EU, Middle East and the Mediterranean. In the interest of maintaining the role it has, and expanding it, EMUNI Staff need to occasionally represent EMUNI in selected events across the institutions.

#### 6 Research

#### 6.1 Support to EMNES project

In 2017 EMUNI continued its administrative support to the coordination of the Euro-Mediterranean Network for Economic Studies (EMNES), which is scientifically led by Centre for European Policy Studies (CEPS), Belgium. The aim of the project is to contribute to the general objective of reinforcing dialogue and promoting socio-economic research and studies in priority themes of the Euro-Mediterranean Partnership, particularly focusing on employment creation and social inclusion, especially among the youth. It is also designed to ensure the dissemination of the results of these studies and research to civil society and socio-economic policy makers. Within the project, researches will be focused on providing policy makers with a renewed vision for socio-economic development in the south Mediterranean countries, mainly focusing on employment creation, social inclusion, and sustainable development. The EMNES project presented significant input into the EMUNI Annual conference 2017 on Youth, Employment and Entrpreneurship.

The EMNES project has been carefully designed to contribute to the general objective of reinforcing dialogue and promoting socio-economic research and studies in priority themes of the Euro-Mediterranean Partnership, particularly focusing on employment creation and social inclusion, especially among the youth. It is also designed to ensure the dissemination of the results of these studies and research to civil society and socio-economic policy makers.

A main objective of the EMNES network is to increase the capacity of research institutions and think-tanks on both shores of the Mediterranean in measuring and analysing trends and challenges in the region due to synergy effects especially fuelled through collaborative research, joint publications, scientific meetings, annual conferences, workshops, and the publication of policy briefs, annual reports and books. Whilst the Northern partners contribute with analytical tools and research methods, the Southern institutes contribute with policy-relevant facts, primary data, and knowledge, experience and dissemination on the ground.

In 2017, EMUNI was co-organiser of the following events held under the EMNES project:

- Presentation of the EMNES-EMEA-IeMED study "How Regional Integration Leads to Youth Employment in the Euro-Mediterranean Region" and fourth Scientific Workshop under the EMNES project was held on 22 July in Barcelona, Spain
- Second EMNES Annual Conference together with the Fifth Scientific workshop of EMNES project was organised by EMUNI together with its partner institution Faculty of Economics and Political Science of Cairo University from 6 to 8 December in Cairo Egypt.

#### 6.2 Implementation of 4PRIMA project

The 4PRIMA Coordination and Support Action will create the bases and will develop a set of activities aimed at supporting the establishment of a long-term, well-structured and integrated partnership for research and innovation (R&I) on food systems and water resources, among countries from both sides of the Mediterranean Sea ("PRIMA Initiative"). In order to enable a sustainable development in this area, 4PRIMA will facilitate the establishment of favourable and stable conditions for a reinforced international cooperation on food systems and water research, based on a better coordination, collective ownership of R&I programmes and, consequently, clear and tangible mutual benefits. 4PRIMA will develop a Strategic Research and Innovation Agenda (SRIA) and an associated implementation plan, as a result of an extensive participatory process that will target a critical mass of key players at international level and all relevant stakeholders of the food and water sectors. To achieve this main objective, 4PRIMA will take advantage of a wide portfolio of results and relationship generated in previous and on-going EU projects, as well as it will seek cooperation between EU and Mediterranean Partner Countries (MPCs), in coherence with the activities of the Strategic Forum for International Cooperation. Given the strategic relevance of an appropriate development and uptake of the SRIA to

establish a long-lasting partnership in the region, 4PRIMA science diplomacy actions will be essential to ensure the support to R&I policy dialogue addressing sensitive challenges between EU and MPCs. Moreover, in order to maximise its expected impact, 4PRIMA project will explore avenues for awareness raising and development of strategic alliances with key stakeholders, including EU, AC and MPCs countries that did not take part to the PRIMA joint programming process, with the goal to enlarge the participation to the "PRIMA Initiative".

In year 2017, EMUNI (co)-organised the following events in the frame of this project:

- **4PRIMA Roundtable Discussion Science Diplomacy and Scientific Mobility** within the PRIMA Initiative was held at EMUNI premises on 7 April 2017 in Piran, Slovenia
- **First PRIMA Stakeholders' Forum** took place on 23-24 April 2017 in Cairo, Egypt where the president of EMUNI was moderating a panel discussion on on Science Diplomacy Approach of the PRIMA project where EMUNI is one of the partner institutions.

# 6.3 Conduct of research within EL-CSID project

In 2017 EMUNI continued to perform research activities and play a role of the work plackage leader in the project titled European Leadership in Cultural, Science and Innovation Diplomacy (EL-CSID), coordinated by Vrije Universitiet Brussels. One full-time researcher was joined by another part-time researcher in the autumn 2017. As the activities are expected to increase in 2018, EMUNI will sustain its efforts.

# 6.4 Project by the Slovenian Research Agency

A 2-year postodoctoral project, with a code Z5-8239 titled «The role of transnational private standards in environmental governance» was tranferred to EMUNI in July 2017. The project will continue throughout 2018, seeking synergies with the existing and new educational and policy activities at EMUNI.

Since October 2017, EMUNI participates in the project number N6-0039: "Yugoslav self-governing experiment and the discussion on the development of European socialism between East and West (1950-1980)" and it is coordinated by ZRS Koper.

# 6.5 Scientific journal IJEMS

International Journal of Euro-Mediterranean Studies (IJEMS - International Journal of Euro-Mediterranean Studies) represent an interdisciplinary contribution to research of topics relevant to the Euro-Mediterranean region. IJEMS is an international journal aimed at promoting intercultural dialogue and exchange between the social environments, human resource development and at ensuring a better mutual understanding of the broad field of the Euro-Mediterranean region. Key issues include policy papers, sociology, economics, growth and development, human geography, environment, business and management, education, international relations, gender studies, life science and history.

The ambition of the IJEMS is to become one of the key periodicals in the regional affairs, of interest both to the scholarly and the academic community. The journal also enables EMUNI to be an outlet for the scientific-research accomplishments of teachers and researchers, who are cooperating with EMUNI, as well as of EMUNI students. Thus, the journal serves as an appropriate textbook for the courses of study programmes and professional upgrading study programmes.

In 2017 EMUNI has continued with the publication of the journal twice per year. Through sustained editorial effort, the quality of the submissions and published articles has been elevated in comparison to the previous year. As such, the journal has demonstrated its capacity-building role of the regional

academics, including some in early-career stages. In 2017, EMUNI has also received a subsidy from the Research Agency for the printing of the publication.

# 6.6 Establishment of e-library

EMUNI gathers its member universities from the South and the North shore of the Mediterranean, therefore an access to literature shall be arranged properly. Since the access to e-library is the easiest and most efficient, EMUNI granted the access to e-library, payable online bases and free online e-books, such as *Google books*, *OpenLibrary.org*, *Project Gutenberg*, *Online Literature Library* etc.

## Establishment of the EMUNI library

EMUNI gives its students access to books of local libraries and higher education institutions. In line with the agreements signed with the University Library of the University of Primorska, where the students are enrolled, and have access to the books. We also provide students with access to the library Srečko Vilhar in Koper.

# 7 Other services and organisation infromation

#### 7.1 IT services, technical support and information communication technologies

Main tasks and goals of the IT unit are defined by direct needs of EMUNI University – to ensure good operating conditions and high efficiency of the information systems.

## Support services are being carried out in different areas:

- support and maintenance of the computer solutions;
- information and communication services maintenance of the information infrastructure;
- office and business systems;
- information security;
- graphical design.

#### 7.2 Social media

Mainly Facebook and Twitter are in use by the EMUNI University among social media. Social networks are used for the distribution of information, news, events links etc.

#### Facebook

EMUNI facebook page works as an addition to the existing EMUNI website. Most information, that is available on the EMUNI website, is also published as posts on facebook page. This brings the news of EMUNI directly to facebook users. Updates are mainly being delivered as a link to the EMUNI website sections. EMUNI Facebook site has 3.647 followers, while the posts in 2017 got 1.375.294 impressions. www.facebook.com/emuni.university.

#### **Twitter**

EMUNI twitter account works as an addition to the existing EMUNI website. Twitter is being used to deliver news to our subscribers through published links. In 2107, 162 posts were posted on Twitter which made 65624 impressions. EMUNI Twitter has 509 direct followers. Twitter address of EMUNI: twitter.com/emuni.

Promotional publications are intended for both, target and wider public to inform them about the activities and events of EMUNI. All promotional publications were issued in e-form to enable the maximum extent. There were over 8.000 recipients of e-publications in 2017, and the number of subscribers to the newsletter continues to grow.

#### 7.3 PR Relations

Public relations are an important factor for international recognition. EMUNI is regularly informing the public about important events. In addition, informing is done through public involvement in the activities of the University (roundtable discussions, press conferences, etc.). Public Relations are particularly intense in the time of EMUNI events (EMUNI conferences, meeting and visits of guests, agreements on common projects), sessions of the bodies of the EMUNI University, at major events and at the beginning of the academic year. In 2017 we continued to inform the public about activities and events of the EMUNI University. In relation to public relations activities the contact network media was updated, a PR report made after major events and media communication.

#### INVESTMENTS AND INVESTMENT MAINTENANCE

No investments were made in 2017. In May 2016, EMUNI moved its seat to a new location, Palace Trevisini in Piran (Kidričevo nabrežje 2, 6310 Piran).

#### 8 ASSESMENT OF THE ACHIEVEMENT OF GOALS

The operation of EMUNI in 2017 was quite successful. We managed to acquire two (2) new projects:

A new master programme **AdapTM**, in which EMUNI will be participating in designing and implementing an interdisciplinary master's degree study programme titled *Smart Environment and Climate Change Management*, which will be modelled in line with the Bologna process. The development of a programme is a result of a successfully gained 3-year Erasmus+ project in a consortium of participating universities. **Erasmus+ KA107** project for staff mobility (Southern Mediterranean Countries) in a consortium with *University of Maribor* and *University of Primorska*. We were granted in total, as a Consortium, 79 mobilities (incoming and outgoing) with Algeria, Egypt, Israel, Jordan, Lebanon, Morocco and Tunisia.

In 2017 EMUNI continued with its good practice on implementing Educational programs, starting with Professional upgrading study programme "Euro-Mediterranean Innovation and Entrepreneurship Diploma" (IEP). In the first part of 2017 EMUNI concluded the 2016/2017 academic year for 18 students, who received full scholarship from Al Alfi Fundation, Egypt. For the academic year 2017/18 the implementation of scholarship scheme for enrolled students was not granted from Al-Alfi Foundation, Egypt. Despite all financial challanges, EMUNI will perform the upgrading study program with its own funds. Again, EMUNI also fully covered the study (tuition fees, accommodation) of 5 students from the Master study programme of "Intercultural Business Communication" (IBC).

As part of the planned study activities we carried out all the set objectives according to the work programme – we organized a training course on blue growth named "Blue Mission" cofinanced by MFA and MESP of RS.

# 9 IMPROPER OR UNEXPECTED EFFECTS OF THE IMPLEMENTATION

The year 2017 was marked with many projects, activities and events. However, EMUNI faced direct and indirect financial challenges. Indirect were related to the workload - working hard to secure new EU funds which could improved the financial condition and could enable new impetus for further development of EMUNI, and notably, the HR challenges with local personnel, which slowed down the general working processes. The direct financial challenge, which significantly marked the 2017 was the reduced financing for the IEP program - resulted in a significant cut into the EMUNI budget. Despite of all these facts, there were no large or unexpected consequences on the implementation of the objectives.

#### 10 SUCCESS ASSESMENT IN COMPARISON WITH PREVIOUS YEARS

EMUNI's growth in success, compared to previous years comes from:

- For the first time in 2017 members of EMUNI General Assembly pay membership fee, which grants them the privilege to become Members of the Inner Circle of the EMUNI General Assembly. Now Emuni has 33 GA Inner Circle Members.
- Having two successfully running education programmes: Euro-Mediterranean Innovation and Entrepreneurship Diploma" (IEP) and "Intercultural Business Communication" (IBC), including a summer course on blue growth named "Blue Mission".
- Signing a consortium agreement with Primorska University and Maribor University for staff mobility.
- And lastly, a new intake of IBC students.

The success was even more significant due to the limitations, which the EMUNI University was confronted with lack of human resources and shortage of finances for its purposes.

#### 11 REVIEW OF THE EFFICIENCY OF OPERATIONS

In assessing the efficiency and effectiveness of operations with respect to defined standards, criteria and measures to improve the efficiency and quality of operations, we derive from the regulation of public funding of higher education and other institutions, principles for the financing of higher education institutions contained in the Higher Education national programme and measures for monitoring, assessment and quality assurance of higher education institutions, study programmess and research, artistic and professional work.

EMUNI disposes with public funds of the budget of the Republic of Slovenia, in accordance with the financing agreement signed with the Ministry of Education, Science and Sport, and at the same time with the Public Finance Act and other legal regulations in this field. EMUNI operates with public funds in accordance with the criteria and standards set for the use of funds by the Ministry of Education, Science and Sport. EMUNI fully complies with the principles of economy and efficiency of operations with funds.

#### 12 EXPLANATIONS REGARDING AREAS WHERE OBJECTIVES HAVE NOT BEEN ACHIEVED

The EMUNI University was successful in 2017 in comparison to previous years, however, some goals were not fully achieved due to various factors. Below the scope and objectives, which were either not met or were only partially achieved, are listed:

In the study area we did not fully achieve the objectives because, since as a university network we mainly depended on the partner institutions and the concluded arrangements. In addition, many questions remain open in relation to the notification and accreditation of study programmes by the SQAA. The plas were optimistic, since 2015, by end of 2017 we could not make progress on this field.

## 13 ASSESMENT OF BUSINESS EFFECTS OF HIGHER EDUCATION INSTITUTIONS ON OTHER AREAS

EMUNI is one of the most important projects of the Union for the Mediterranean. It focuses on bringing together universities, research institutions, research centers and centers of excellence for the joint work in developing new programmes and projects aimed at bridging the gap between the north and the south, east and west of the Mediterranean region.

The priority areas of EMUNI include higher education and research, intercultural business communication and connections, sustainable conservation of the Mediterranean area, maritime and land highways, alternative energies and civil protection. These topics are dealt within the context of EMUNI summer schools/courses, research seminars, European projects and intensive programmes, which involve students, young graduates and academic staff, whose goal is to create a common language of the region - the language of research and excellence. EMUNI partner universities help in creating the foundations of intercultural dialogue and common sustainable growth, as they focus on themes and topics that directly relate to the Euro-Mediterranean region. With the personel mobility program the process of intercultural exchange is getting positive impacts on both sides, host and guest institutions.

Thematically, EMUNI focuses on the priority areas of the Union for the Mediterranean and on other areas that are of most interest for the international community, including business development and economic studies, marine issues, culture and tourism, human rights, migrations, gender issues,

development studies, water management and regional integration. Study activities that are carried out in collaboration with partner universities (e.g. summer schools/courses, professional upgrading study programmes, etc.) are through the optional and mandatory study courses also connected to the areas listed above.

In the year 2017 and in the academic year 2017/2018 EMUNI will contribute to the creation of a single, integrated Euro-Mediterranean higher education, science and research area. EMUNI already serves as a center for the creation of institutional networks, exchange of students and projects in the Euro-Mediterranean region. According to the results achieved in 2017 it will continue to actively contribute to the research and academic staff and to development of joint study programmes.

#### 14 OTHER EXPLANATIONS

The explanations that supplement the report on the operation of the EMUNI University in 2017 are described in detail in the following paragraphs.

# 14.1 Report on the implementation of the tasks under the contract no. C3330-16-500022

In 2017 the EMUNI University realized the following obligations under the contract No. C3330-16-500022, which are listed in the Article 5:

- until the 10<sup>th</sup> day in the current month delivered a request for the payment of funds for the current month and report on its work and the dynamics of expenses and incomes,
- sent the annual report for 2016 and report on the performance of the contract to the Ministry until 28. 2. 2017,
- with the funds for labor costs and costs of goods and services co-finance the costs of management and professional services of the EMUNI University, activities related to the preparation and implementation of study programmes in the academic year 2016/2017 and the costs of the facilities in the amount and in the manner as specified in the annual work programme for 2017, which was adopted by the Management Board of the EMUNI University at its Management Board at its 35th session, which was held on 9 December 2016.
- Monitored the budget spending on a separate cost center/source of funding, so it is possible to verify the implementation of this contract,
- Operated rationally and carried out tasks which are co-financed from the state budget, exercising all due diligence,
- Use the received funds for the purposes specified in the contract,
- Enabled the Ministry to monitor the implementation of the above mentioned contract within the monthly report of revenues and expenditures and explanations that the ministry demanded in 2017.

Regarding the 11<sup>th</sup> indent of the Article 5 contract regarding the submission of the the annual report for 2017, the ministry did not require business and documentation insight concerning the compliance with the above-mentioned contract. The EMUNI University will - at the request of the Ministry – enable the insight into the operations and documentation.

## 14.2 Personnel policy analysis

On 31. 12. 2017 EMUNI had 7,45 employees. The average number of employees in 2017 amounted to 6,91 FTE.

#### 15 ACCOUNTING INFORMATION FOR EMUNI UNIVERSITY FOR 2017

# Main accounting principles

The Financial Report of the EMUNI University for 2017 has been drawn up in line with the Accounting Act (Official Gazette of the RS No. 23/99 30/02-ZJF-C and 114/06-ZUE) and the Slovenian Accounting Standard 36 - Accounting Solutions in Not-for-Profit Organisations - Private-Law Legal Entities (Official

Gazette of the RS No. 118/05) and the Account Scheme for Not-for-Profit Organisations (Official Gazette of the RS No. 7/11, 34/11 – CC Decree, 64/12 and 12/13).).

When drawing up accounting statements the EMUNI University follows the following general principles of evaluation:

- Principle of continuity;
- Principle of consistency and
- Principle of timeliness.

The accounting statements and notes reflect the true and fair situation of operations.

## Balance Sheet - general rules

The Balance Sheet is drawn up for a financial year, which is equal to the calendar year. The Balance Sheet as of 31<sup>st</sup> December 2017 shall also contain a column with data from the Balance Sheet as of 31<sup>st</sup> December 2016.

When providing explanations on the balance sheet items EMUNI University takes into account the rules on the content, layout and format of the financial statements.

Assets and liabilities are broken down per type and maturity.

#### Intangible and tangible fixed assets

The types of intangible fixed assets are defined in line with SAS 2, while the types of tangible fixed assets pursuant to SAS 1. They are measured in line with the SAS an initially recognised at their procurement cost. The procurement cost is composed of the purchasing price, the import and non-reimbursable duties and the costs of set-up for destined use. Any commercial or other discounts are subtracted from the purchasing price.

The residual value of intangible long-term assets and tangible fixed assets pursuant to SAS 1.17 and SAS 2.20 is disclosed in the Balance Sheet as the difference between the procurement value and the accrued correction of the value. The procurement value and the accrued corrections of value for tangible fixed assets and intangible long-term assets are disclosed separately in the accounting statements.

The depreciation of tangible fixed assets and intangible long-term assets is calculated individually on a regular basis by using the proportional method, consistently applied in each accounting period. The annual depreciation rates are set freely by the University. The net carrying amount of an item of tangible fixed assets is the difference between the cost of the item and its accumulated depreciation.

Tangible fixed assets, whose individual procurement value, as per the supplier's invoice, does not exceed EUR 500, are disclosed among small tools.

Individual items in the small-tools category, whose procurement value does not exceed 500 EUR are categorised as materials.

## Short-term operating receivables

As of 31<sup>st</sup> December 2017, the University had 87.620 EUR worth of short-term operating receivables from:

- short-term receivables to the customers in Slovenia 17.025 EUR;
- short-term receivables to the customers abroad in the amount of 20.968 EUR;
- short-term receivables from the pre-granted advances in the amount of 998 EUR;
- Short-term receivables from advances made in the amount of EUR 5.809 EUR were paid to Nova KBM Bank, and the university gave a 1.500 EUR guarantee to the Adriatic Slovenica d.d. for the rent, and EUR 2.417 EUR given to Nahala's advance arises from previous years;
- other short-term receivables to the physical persons in total of 38.903 EUR, predominantly addressed to the former EMUNI University president prof. dr. Joseph Mifsud.

#### Cash at hand

EMUNI University does not operate with cash, i.e. it does not cover costs of material by cash.

#### Cash at bank

The amount of cash in the current account, held at Nova KBM and Unicredit, amounted to 331.271 EUR on 31<sup>st</sup> December 2016.

#### Deferred costs and accrued revenues

As of 31<sup>st</sup> December 2017, the value of the deferred costs amounts to 744 EUR, that is coming out from bank card membership.

#### Short-term liabilities to employees

The average number of employees based on the working hours in the year 2017 was 6,91.

On 31<sup>st</sup> December 2017 EMUNI University was obliged to the employees for the payment for the December salary and salary related costs and travel orders in the amount of 37.687 EUR. Liability arising from the travel orders predominantly arises from the former president's travel orders. Short-term liabilities to employees from the unpaid salaries also comes from last unpaid salary to Joseph Mifsud in the amount of 4.800 EUR gross.

#### Short-term liabilities to suppliers

EMUNI University's short-term liabilities to suppliers on 31<sup>st</sup> December 2017 amount to 33.868 EUR and consist of liabilities:

- to domestic suppliers in the amount of 27.026 EUR and
- to foreign suppliers in the amount of 6.842 EUR.

- EMNES in the amount of 15.471 EUR and the period from March 2015 to February 2018.
- CMEPIUS in the amount of 55.012 EUR and the period from 1<sup>st</sup> August 2017 to 28<sup>th</sup> July 2019.
- Slovenian Research Agency in the amount of 22.095 EUR and the period from  $1^{st}$  July 2017 to  $30^{th}$  June 2019.
- Employment Agency of RS in the amount of 2.064 EUR for the employment scheme of unemployed person, for the period of one year.

# Surplus of expenditures over revenues

In 2017, EMUNI University generated 139.860 EUR in surplus of revenues over expenditure. Along with the surplus of expenditures over revenues from the previous year in the amount of 55.406 EUR, the final surplus of expenditures over revenues amounts to 84.454 EUR on 31<sup>st</sup> December 2017. The surplus of revenue over expenditure exists due to the funds received for projects that last several years and were not fully used in the current year. More specifically, the funds belong to project partners and not to EMUNI. Due to the inability to transfer the projects funds to some partners outside EU, eg the Iranian partner in Project MERID as the Slovenian banks cannot transfer funds to Iran. Most of this surplus will be dispensed to the project partners in the year 2018, since the concerned project will end in that year.

- funds from the budget of RS (MESS) in the amount of 204.300 EUR or 22,58% of total revenues,
- funds from the Employment Agency of RS in the amount of 2.936 EUR or 0,33% of total revenues,
- funds from the fees of the EMUNI General Assembly in the total amount of 22.310 EUR or 2,47% of total revenues,
- funds from CMEPIUS project in the amount of 14.477 EUR or 1,60% of total revenues,
- funds from ERC Science Squared project the amount of 3.078 EUR or 0,34% of total revenues,
- funds from MERID project in the amount of 372.342 EUR or 41,16% of total revenues,
- funds from JMM project in the amount of 3.129 EUR or 0,34% of total revenues,
- funds from EMNES project in the amount of 92.826 EUR or 10,26% of total revenues,
- funds from EL-CSID project in the amount of 113.975 EUR or 12,60% of total revenues,
- funds from PRIMA project in the amount of 63.000 EUR or 6,96% of total revenues,
- funds from Slovenian Research Agency in the amount of 7.365 EUR or 0,81% of total revenues,
- funds from MFA of RS in the amount of 4.990 EUR or 0,55% of total revenues.

#### Revenues from financial activities

EMUNI University had revenues from financial activities in the amount of 4 EUR in 2017.

#### Other revenues

EMUNI University had other revenues in the amount of 2.110 EUR in 2017 (those refer to positive currency differences).

#### Costs of material

The EMUNI University had a total of 7.680 EUR of costs of material or 1,01% of all costs, in particular for utility and maintenance.

#### Costs of services

In 2017 the University had 490.163 EUR of costs for the services or 63,91% of total costs as follows:

- Costs of business travel in the amount of 63.343 EUR or 8,26%;
- Costs of rent in the amount of 29.816 EUR or 3,89%;
- Cost of authorials in the amount of 68.314 EUR or 8,91%,
- Costs of royalties in the amount of 51.777 EUR or 6,75%;
- Costs of payment transactions in the amount of 1.792 EUR or 0,23%;
- Costs of insurances in the amount of 4.078 EUR or 0,05%;
- Costs of advertising and entertainment in the amount of 12.597 EUR or 1,64%;
- Costs of telephone and postal services in the amount of 4.652 EUR or 0,61%;

- Costs of occasional intellectual services in the amount of 14.583 EUR or 1,90%;
- Costs of co-financing of MERID project by contract nr. 645846 in the amount of 189.742 EUR or 24,74%;
- Cost of the co-financing of ERASMUS project in the amount of 23.843 EUR or 13,11%;
- 25.626 or 3,34% of the cost of services represent the cost of other services such as training costs, meals and transportation to the work of employees, insurance premiums, costs of payment transactions and other costs.

#### Labour costs

Labour costs accounted to 266.227 EUR and represent 34,71% of total costs. They consist of:

- salaries and other salary reimbursement in the amount of 165.396 EUR,
- pension insurance contribution in the amount of 52.233 EUR,
- social security contributions in the amount of 29.495 EUR,
- other costs of work in the amount of 19.103 EUR.

#### **Amortisation costs**

In 2017 EMUNI University had a total of 1.913 EUR of amortisation or 0,25%.

#### Other costs

In 2017 EMUNI University had a total of 923 EUR of other costs or 0,12 % of total costs.

#### Financial costs

EMUNI University had financial expenses in the amount of 36 EUR in 2017.

# Other expenses

EMUNI University had other expenses in the amount of 39 EUR due to outstanding costs and negative cent levelling.

#### Surplus of expenditures over revenues

As seen in the Statement of revenues and expenditures the surplus of revenues over expenses achieved with the operation of EMUNI University in the year 2017 amounted to 139.860 EUR. Along with the surplus of expenses from previous years in the amount of 55.406 EUR, the final surplus of expenses over revenues on 31<sup>st</sup> December 2017 amounts to 84.454 EUR.
