1 VISION AND MISSION

1.1 Vision

The international **Euro-Mediterranean University** (EMUNI University), which is set up in Slovenia, will significantly contribute to the harmonization of higher education and research area and contribute to the lasting development of the wider social-economic and cultural environment in the EUROMED countries as well as recognition of Slovenia in the region – Union for the Mediterranean.

1.2 Mission

EMUNI University is an international university based in Slovenia. It represents one of the six projects of the Union for the Mediterranean, which were confirmed within the common declaration and adopted in Paris on 13 July 2009. The mission of EMUNI University is above all:

- improving the quality of higher education with study and research programme implementation;
- to become an international university, taking into consideration cultural diversity;
- establishing university environment, which will have a stimulating effect on connecting different nations and cultures in an academic sphere;
- ensuring administrative, operative and material infrastructure, thus enabling university operation.

The goal of the EMUNI University is to establish an excellent network of specialised study programmes among the Euro-Mediterranean universities. The study programmes will be internationally comparable from the duration, credit points, content and acquired scientific and professional titles point of view. They will cover themes and fields which are important for the Euro-Mediterranean space. The study programmes or parts of them will be conducted in Slovenia and at various universities, cofounders of the EMUNI University.

One of the main activities of the EMUNI University is also the research activity, which is also one of the important factors for development, success and quality of the university.

The basic mission of the university is to contribute – with its activities in the field of higher education and research – to the strengthening of inter-cultural dialogue in the Euro-Mediterranean region and to fortify the Barcelona Process, which is – in a wider sense – included in the Union for the Mediterranean also.

Since its establishment in 2008, the Euro- Mediterranean University, one of the priority projects of the Union for the Mediterranean, has become an international institution, gathering expertise and knowledge from the Euro-med countries and through this contributing in an important extent to the creation of a unified, integrated Euro-Mediterranean Higher Education and Research Area.

The University performs mainly all its activities at its headquarters in Portorož, where spatial conditions are provided for some of its operation. When needed additional space is rented at nearby academic institutions.

EMUNI University performs study activities in all study fields, designated according to the international Isced classification (UNESCO, 1997). EMUNI University organises the implementation of study programmes, accredited at the partner universities in Slovenia and at various EMUNI member universities. The university performs research activities in all scientific research fields, classified by the international Frascati classification (UNESCO, 2002).

EMUNI University is gaining recognition in the regional, national and international environment.

Important dates:

- February 2009: Registration in court register
- June 2009: The first study programme, already accredited at the University of Maribor, was accredited at EMUNI.
- July 2009: EMUNI entered into the Register of Higher Education Institutions of the Republic of Slovenia.
- December 2009: Erasmus University Charter awarded to EMUNI University.
- July 2011: Two II. Level Master study programmes ("Business Communication in Intercultural Dialogue" and "Environmental Analysis and Management") were registered at the Registry of higher education institutions at the Ministry of Education, Science, Culture and Sport (MESCS).
- July 2012: Former EMUNI University president prof. Joseph Mifsud resigned from his position and Laris Gaiser, M.A. has been nominated Acting President for an interim period until July 2013 when a new president shall be appointed.
- July 2012: In line with EMUNI University's recruitment plan the Management Board appointed Mr. Gaiser also as a new Vice President for Administration and Finance.

The Activities of EMUNI University in 2012 were financed from various sources:

- the public budget of the Republic of Slovenia by Ministry of Education, Science, Culture and Sport (MESCS) in the amount of 384,697.80 EUR,
- EMUNI Foundation in the amount of 169,822.63 EUR for the ENPI project experts fees payment, study programmes implementation and EMUNI staff costs payment,
- I.N.P.D.A.P General Directorate in the amount of 141,800 EUR for the INPDAP/EMUNI Master programme scholarships,
- European Commission ADICO for ENPI project incidental expenditure in the amount of 30,640.17 EUR,
- ICMPD in the amount of 9,117.00 EUR as part of the Euromed Migration III project profit share instalment,
- Other sources in the amount of 8,642.77 EUR, which include market revenues, long-term sickness salary refunds, re-invoicing of accommodation costs and reimbursement of travel costs.

The Government of Slovenia is supporting the operations of EMUNI University also indirectly by providing the premises for University's administration and study programmes implementation as well as the dormitory. From 2007 to 2012 the Government of Slovenia allocated around 3 mil EUR to EMUNI firstly through EMUNI Center and subsequently by direct funding.

The European Commission funds the activities of EMUNI University through the ENPI project. 1 million EUR in the period of 2010 to 2013 is planned to be allocated to EMUNI.

EMUNI University is funded by donations as well, channelled through the EMUNI Foundation. Since September 2008, EMUNI Foundation has provided 0.65 mil EUR for University's activities, by financing scholarships and grants, development of study programmes, research projects and other activities. In 2012 EMUNI Foundation agreed to provide the financing needed for the payment of ENPI experts' and team leader's fees. The loan value is 116,000 EUR and will be drawn for the rolling repayments of fees and reimbursements from the European Commission that shall take place in approximately 8 phases.

EMUNI received funding also through other EU-funded projects, such as EUROMED-Migration II, Erasmus etc. EMUNI University was successfully selected as a consortium partner in other EU projects in 2012 and the funding of project activities is planned to commence in the year 2013. Several other project applications are planned in the future, which will increase EMUNI's cash flow along with the tuition and registration fees that shall be received once the study programmes start being implemented in autumn 2013.

EMUNI and the Union for the Mediterranean

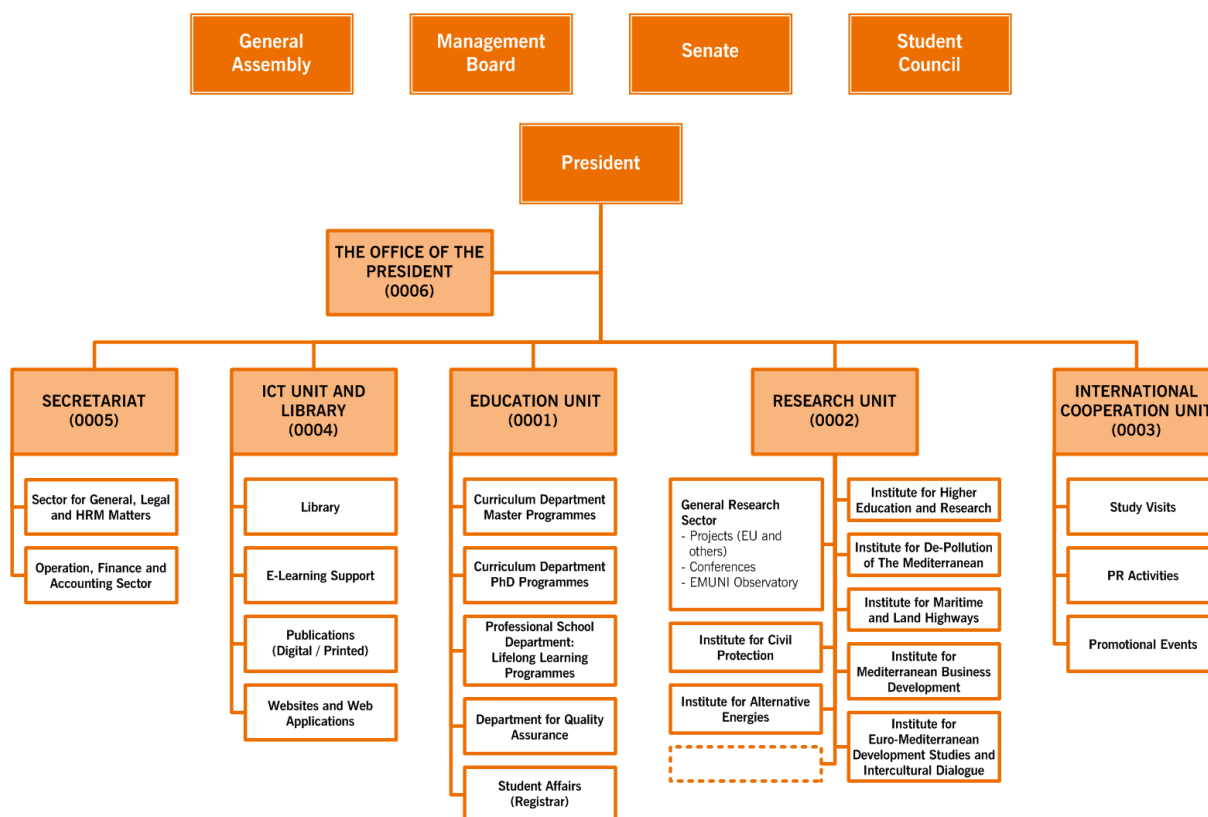
The Union for the Mediterranean is a partnership forum for dialogue between the member states of the European Union and countries of Africa and Middle East countries in the Mediterranean Basin, with the aim of strengthening relations among them. It was created as a re-launched Euro-Mediterranean Partnership in 2008.

The Union for the Mediterranean is a multilateral partnership with the aim of increasing the potential for regional integration and cohesion among Euro-Mediterranean partners. The Union for the Mediterranean is inspired by the shared political will to revitalize efforts to transform the Mediterranean into an area of peace, democracy, cooperation and prosperity. The creation of a joint secretariat is a key stone in this partnership. The Secretariat will contribute to reinforcing co ownership of new Mediterranean relations and achieving visibility through economic projects.

2.1 Organisation of EMUNI

Organisation structure

The organisation chart of EMUNI University is presented below.



Upon consent of the Management Board the President of the University can determine other internal organisational units (Article 33).

2.1.1 University bodies

EMUNI is organised as an international university with a seat in Portorož, Slovenia. It has the following bodies:

- Management Board
- General Assembly
- Senate
- Student Council

President: President ex officio Laris Gaiser, MA (nominated on 23 July 2012 upon resignation of the former President)

The President is the executive and expert body of the University, as well as its legal representative. His duties and tasks are defined in Article 27 of the Statute of EMUNI University.

The President is supported in his duties and responsibilities by a Vice President for Academic Affairs (not appointed yet) and a Vice President for Administration and Finance, whose tasks are defined in Article 30 of the Statute of EMUNI University. In the absence of the President, for any reason whatsoever, the more senior of the two Vice Presidents shall assume the President's duties ex officio provided that, in such circumstances, he shall consult and coordinate with the remaining Vice President.

Vice President for Administration and Finance: Laris Gaiser, MA (appointed on 12 July 2012)

The Management Board is a University management body. The Management Board is constituted of 8 members coming from 6 countries, i.e. by:

- Prof. Hassan Nadir Kheirallah, Alexandria University, Egypt - Chairman
- Prof. Danijel Rebolj, Rector of the University of Maribor Slovenia,
- Prof. Ilan Chet, Union for the Mediterranean, Spain,
- Prof. Francesco Paolo La Mantia, University of Palermo, Italy
- Dr. Christofer Soler, University of Malta
- Dr. Oto Luthar, EMUNI Foundation
- Peter Volasko, EMUNI Foundation
- Prof. Anasse Bouhlal, Tampere University of Applied Science, Finland

The Chairman of the Management Board is Prof. Dr. Hassan Nadir Kheirallah (since 12 July 2012). Duties of the Management Board are defined in Article 18 of the Statute of the EMUNI University. As a rule the Management Board meetings shall be convened by the Secretariat three times a year, i.e. in February, June and November, upon motion of the President of the University or of one third of the members of the General Assembly.

The Management Board, among other tasks, adopts the Work Programme with the financial plan for the University.

General Assembly – is usually summoned every year to discuss the general policies and guidelines of the work of the university. Every cosignatory of the Foundation Charter of the Euro-Mediterranean University shall have one representative to the General Assembly. Higher education, research and other institutions and/or organisations, who have applied for membership with the Secretariat and whose membership has been approved by the General Assembly, will also be entitled to each appoint one representative to the General Assembly.

Representations at the General Assembly sessions:

- GA 2009: 114 members from 32 countries
- The Co-chairmen of the GA 2009 were Prof. Hassan Nadir Kheirallah and Prof. Maurits Van Rooijen.
- GA 2010: 141 members from 37 countries
- The Co-chairmen of the GA 2010 were Prof. Giuseppe Giliberti and Prof. Ahmed Nouredine Helal.
- GA 2011: 206 members from 42 countries
- The Chairman of the GA 2011 was Prof. António Sampaio da Nóvoa.
- The GA for the year 2012 is taking place in February 2013.

Duties of the General Assembly are defined in Articles 14 and 15 of the Statute of the EMUNI University.

The General Assembly shall be convened by the Secretariat as the need arises. However, as a rule it shall be summoned once a year, i.e. in November, by taking into consideration the Register of the signatories of the Charter, i.e. of all parties exercising their founders' rights, as well as of the members of the General Assembly, which is kept by the Euro-Mediterranean University.

The Senate is the expert academic body of the University, which is mainly responsible for study programme activities. The Senate is constituted by the president of the university and 12 professors from 12 different partner universities and 12 countries:

- Mr. Laris Gaiser, acting President of EMUNI University, Slovenia
- Prof. Dr. Anasse Bouhlal, Tampere University of Applied Sciences, Finland
- Prof. Labib M. M. Arafah, Al-Quds University, Palestinian Authority

- Prof. David Faraggi, University of Haifa, Israel
- Prof. Giuseppe Giliberti, University of Urbino "Carlo Bo", Italy
- Prof. Pantelis C. Kelires, Cyprus University of Technology, Cyprus
- Prof. Alejandro del Valle Galvez, University of Cadiz, Spain
- Prof. Jacek Ireneusz Witkoś, Adam Mickiewicz University, Poland
- Prof. Panagiotis Grigoriou, University of the Aegean, Greece
- Prof. Maria Amélia Martins-Loução, University of Lisbon, Portugal
- Prof. Rowaida Maaitah, Hashemite University, Jordan
- Prof. Jilani Lamloumi, University of Gabès, Tunisia

The University Senate shall be chaired by the President of the University, and its duties are defined in Article 21 of the Statute of the EMUNI University. Meetings of the Senate are convened by the President of the university three times a year – usually in February, June and November.

The Senate can appoint experts and commissions or other working groups in order to prepare statements, opinions and proposals, or to carry out tasks or assignments of a demanding, comprehensive or periodic nature.

Permanent commissions, appointed so far:

- Commission for study affairs (responsible for study affairs and quality assessments and assurance)¹;
- Commission for University Networks and Research Potential in the Euro-Med Area;
- Commission for Universities and Communities in the Euro-Med Region;
- Commission for Innovative Pedagogy within the EuroMed Higher Education and Research Area
- Commission for preparing a policy document on the admission of new members

Temporary commissions (for specific projects):

- Commission for developing the EMUNI Projects Award.
- Commission for the Statute

The student body, made up of all students enrolled in study programmes organized and/or implemented by the University, shall elect five (5) members which shall form the **Student Council**. Student Council's duties are defined in Article 31 of the Statute of the EMUNI University and its meetings are convened by the University at the proposal of the president of the Student Council.

The Student Council of the University will be constituted when the University has its own students. A policy statement of the students' participation in the operation of the EMUNI University is being prepared.

¹ The Commission for study affairs has been renamed Academic Commission of the Senate. It is split into two divisions: Study Affairs Commission and Research Commission. This decision was taken by EMUNI University's Senate during its latest session on 26th November in Lisbon.

General Assembly:

EMUNI University's General Assembly 2012 has been postponed until 23rd February 2013 due to extraordinary circumstances in the organization, restructuring and financing of EMUNI University that was taking place in the second half of 2012. The General Assembly is to be organized at the same time and in the same place as the EMUNI Management Board and Senate February sessions, during which the new Management Board and Senate will be constituted due to the expiration of the mandate of the current bodies.

The 10th session of EMUNI University's Senate and the 13th session of the Management Board were held on 23rd and 24th February in Barcelona, Spain. The most important decisions and discussions held during both sessions are summarised below:

- start the implementation of the 2 notified Master SP: Intercultural Business Communication in cooperation with the University of Urbino and the Master in Environmental Analysis and Management in cooperation with the University of Palermo plus a PhD in Criminal Justice and Security Studies in cooperation with the University of Maribor;
- implementation of the already accredited Master SP through the participation of a call for scholarships of the Italian Minister of Labour;
- adoption of Summer school, Doctoral research seminar and EMS in English, French and Spanish;
- selection of institution to host the Master SP in the framework of ENPI as well as the marketing of these programmes;
- approval of the 2011 Annual Report and Financial Statements;
- support of the endorsement of a contract to be signed for Springer Publishing to publish IJEMS;
- decision about different types of membership to EMUNI University;
- the members of the Management Board decided that no Vice President is hired until additional funding is made available.

The 11th session of EMUNI University's Senate and the 14th session of the Management Board were held on 11th and 12th June in Brussels, Belgium. During the sessions the following decisions were taken by the members:

- evaluate the progress of the EMUNI Master SP and the progress of the Master SP in the framework of ENPI;
- adoption of new criteria for labelling a Master or a PhD SP;
- the adoption in each country of a representative of EMUNI, i.e. a focal point with the aim to establish an EMUNI confederation at the international level;
- organisation and implementation of the Euro-mediterranean studies at the EMUNI antenna: University of Naples "L'Orientale";

- the members of the MB accepted the resignation of Prof. Joseph Mifsud as President of EMUNI. The Management Board agreed to the consensual amicable resignation of the President of EMUNI University as from the 1st September 2012;
- the members of the MB accepted the nomination of Mr. Laris Gaiser as EMUNI University's Vice-president for Administration and Finance;
- the members of the MB decided to launch a call for tender for the New President of EMUNI University;
- after the resignation of the President Prof. Mifsud a second MB session was set up in Brdo pri Kranju (Slovenia) on 23rd July 2012;
- the members of the MB accepted to nominate Mr. Gaiser as ad interim President of EMUNI University with the support of Prof. Joseph Mifsud and Mr. Oto Luthar as a part time counsellor for the following until the election of the new President.

The 12th session of EMUNI University's Senate; due to logistic reasons it was not possible for the meeting of the Senate to take place in person, therefore a correspondence session, in which all members of the Senate were involved, was organized. The discussion was open between 12th and 14th December 2012, upon which the casting of votes took place. The following main decisions were adopted:

- confirmation of the programme of EMUNI University Master Study Programme: Euro-Mediterranean and Intercultural Studies, and starting its accreditation procedure;
- confirmation of the Standards for the appointment of higher education teachers, researchers and faculty assistants at Euro-Mediterranean University;
- confirmation of the Quality Manual at Euro-Mediterranean University.

The 16th session of the Management Board was held on 14th December in Portorož, Slovenia. At the session the members discussed several topics and some major decisions were adopted:

- the adoption of the Work Programme and Financial Plan of EMUNI University for 2013;
- the members decided to postpone the 5th EMUNI General Assembly until the third week of February 2013, due to extraordinary circumstances in the organization, restructuring and financing of EMUNI University;
- the members of the MG decided to adopt the proposed decision and to extend the mandate of the current Management Board for another two months. A new Management Board could then be elected during the General Assembly.

2.1.3 EMUNI Members and Agreements

EMUNI University's network is confirming its strength and prominence in Euro-Mediterranean region. As of December 2012 the network consisted of 204 member universities and institutions. EMUNI University has also 51 memorandums of understanding, 10 agreements and 2 declarations signed. In 2012 EMUNI received 7 Letters of Intent; together we have 37 Letters of intent. The full list of EMUNI members and agreements are listed in the Appendices 1 and 2.

3 POLICIES AND GOALS

3.1 Law and other legal basis

The Euro-Mediterranean University is a University established by means of the Euro-Mediterranean University Memorandum of Association in conformity with the Foundation Charter of the Euro Mediterranean University and pursuant to the Act Amending the Higher Education Act (Ur. I. RS, No. 64/08).

EMUNI University is an international University with the seat in Slovenia, organised as a Slovenian legal entity registered as a private institution. Being registered in Slovenia, the University is bind to Slovenian legislation.

Basis for operations:

- Law on Higher Education (OG RS, No. 32/12-UPB7, 40/12-ZUJF and 57/12-ZPCP-2D)
- Act amending the Higher education act (OG RS, No. 64/2008)
- The Euro-Mediterranean University Statute, adopted on 26 November 2008 at the General Assembly in Barcelona, Spain on the basis of the article 10.a of the Act amending the Higher education act (Ur. I. RS, No. 64/2008) and in line with the article 37 of the Euro-Mediterranean Act and taking into account the Charter of Establishing the Euro-Mediterranean University and the »Joint Declaration of the Paris Summit for the Mediterranean« (Paris, 13 July 2008). On 27 November 2010 and 25 November 2011 the General Assembly adopted the Statute amendments.
- The Euro-Mediterranean University Memorandum of Association adopted on 26 November 2008 at the General Assembly in Barcelona, Spain.

3.2 Long-term strategy and objectives

EMUNI University's long term strategy is to become a leading international university, acting as international organization, in the Euro-Mediterranean region to bond together higher education institutions and its experts in the region and to develop common study programmes in the scope of the priorities of the Union for the Mediterranean.

3.3 Mid-term goals for period 2012-2014

4 INVESTMENTS

In 2012, EMUNI University did not have any investments property wise. The university uses the offices in the Dijaški Dom on the 4th floor, which is also the seat of the University. EMUNI University had several meetings in 2012 to obtain new premises for the seat of EMUNI University.

The premises, where EMUNI University is currently located, are owned by the Republic of Slovenia. As per the contract currently in place the premises in use are rent-free and the University is in charge of paying utility and maintenance bills. Since 2011 EMUNI University has been working with the Ministry of Education, Science, Culture and Sport towards preparing the best possible contract for these premises. Nevertheless, EMUNI University received several claims for payment of rent at the total value of 51,822.08 EUR relating to the period from 30 September 2009 on, i.e. is from the time the first contract for free use of premises expired. EMUNI University has rejected all Ministry's claims based on the fact that after the contract had expired an analogue situation has been preserved since the Ministry acceded to the resolving of this matter only in 2011.

On a positive note, the Republic of Slovenia has committed to supporting EMUNI University's activities and since EMUNI is an international institution the issue of the premises is currently being resolved by the Ministry. We expect a continued rent-free use of premises to be agreed in early 2013.

5.1.2 Accreditation with Slovenian Quality Assurance Agency for Higher Education (SQAA)

In October 2012, EMUNI University started with the preparation of the accreditation proposal for the MA study programme Euro-Mediterranean and Intercultural Studies with the Slovenian Quality Assurance Agency for Higher Education. For this purpose, the detailed accreditation proposal with full description of the programme, its social components, material and financial conditions, quality assurance, etc., was needed, as well as a number of documents, such as syllabuses for the 13 courses, proofs of valid appointment and declarations of cooperation for all lecturers, comparison with foreign relevant study programmes, criteria for appointments to positions for higher education professors and quality manual of EMUNI University, agreements with companies on practical training, etc.

The decision on the accreditation proposal by SQAA is expected to be known in 2013.

5.1.8 Overall Assessment of the objectives

We estimate that EMUNI University operated successfully in year 2012 despite the financial constraints following the decreased budget and the long process of securing the funding needed to fulfill the ENPI project payment obligations. EMUNI University had been trying to secure funds for more than 18 months. Thanks to the loan from EMUNI Foundation and the European Commission's approval of the payment process extension until 30th June 2014, the payment process of ENPI expert's fees and team leader's fees could finally commence in December 2012.

In 2012 EMUNI University managed to partly resolve its liquidity issues and also partly repay the outstanding obligations from 2011 and 2012. Thanks to the successful implementation of the EMUNI/INPDAP study programmes, the release of funds of the Migration project and a loan from EMUNI Foundation dedicated to the payment of staff costs and EMS module, a large portion of outstanding obligations to suppliers and staff has been paid.

Our main operational, research and study objectives were achieved. Following EMUNI University's top management changes, the University started with the activities of work reorganisation and processes streamlining with the aim to achieve a more efficient way of achieving its objectives by taking into account also the Act on the Balancing of Public Finances. Apart from the reorganisation EMUNI University also performed an internal audit of its accounts in order to evaluate the financial performance and financial position as at 31st August 2012 when the new management started its mandate.

Since the new management's main focus was the improvement of financial performance and working processes, the main activities linked with the launch of the study programmes were postponed until autumn 2013, which allowed for the reorganisation to take place along with finding solutions for the pending issues. A major focus was given on the accreditation process whereas EMUNI University now has a full time dedicated resource in charge of the accreditation. A co-operator was also hired on a contractual basis to boost the accreditation application process.

EMUNI University's improved financial position can be seen from the year-end result, which was significantly better than the result achieved in 2011. The loss was partly due to the decreased value of the contract with MESCS (the budget was cut from last year's 384,697 EUR to 338,985 EUR in 2012), but also due to over-expenditure on travel costs in the first half of the year during the former management mandate.

Similarly to 2011 also the year 2012 was marked with a prolonged funding procedure of the European Commission linked to the ENPI project. EMUNI University was facing issues in paying the fees associated with the project's experts due to lack of funds. Thanks to the loan from EMUNI Foundation the payment process of ENPI expert's fees and team leader's fees commenced in late 2012.

5.2 Assessment of operational impacts on other areas, particularly the economic, social, environmental protection, regional development and spatial planning

EMUNI University has been established as one of priority projects of the Union for the Mediterranean, so its impact on other areas, rather than education, is extremely vast.

EMUNI is one of the most important projects within the context of the Union for the Mediterranean focused on bringing together universities, research institutions, research centres and centres of excellence to work together in the development of new projects, bridging the South and the North, the North and the South, the East and the West of the Mediterranean.

EMUNI's priorities have ranged from maritime and land highways to alternative energies, from civil protection to higher education and research. It has also focused on such important areas like the development of Mediterranean business, especially small and medium enterprise and cottage industries. Professional development schools, summer schools, research seminars, European projects and intensive programmes were all developed and implemented with the aim to bring together young people, young graduates from all over, to work together and to speak together the same language, the one of research and excellence.

EMUNI partners share with the University the trip of intercultural dialogue by focusing specifically on themes and thematic approaches.

EMUNI University is not just a European institution, but also a Euro-Mediterranean institution, and its experts come from various industries within the Mediterranean basin. EMUNI's goal is to be an instrument of change and development for the region.

Thematically EMUNI focuses on the Priority Areas of the Union for the Mediterranean, as well as on other areas that are currently of focal interest of the international community, such as: Maritime and Land Highways, Civil Protection, Use of Alternative Energies, Higher-Education and Research, Business Development and Economic Studies, Maritime Issues, Culture and Tourism, Human Rights and Migration, Euro-Mediterranean Studies, Gender Issues, Development Studies, Water Management, Performing Arts and Regional Integration.

With the establishment of the Euro-Mediterranean University an important contribution towards creating a unified, integrated Euro-Mediterranean Higher Education, Science and Research Area was made. EMUNI is serving as a hub for networking of institutions, exchanges of students, research and academic staff, development of joint study programmes and projects in the Euro-Mediterranean region.

Overview of hiring at the University in period from 1st January 2012 to 31st December 2012:

In 2012 EMUNI University did not hire any new employees, except for the changes, which occurred in the position of the President. In July 2012 the previous President Prof. Dr. Joseph Mifsud resigned from the position, therefore the acting Vice President for Administration and Finance Mag. Laris Gaiser was confirmed by the Management Board as the Acting President of the University until a new President is elected.

Extension of contracts, leavers and other collaborators:

Two Employees left EMUNI University in 2012:

- one employee for research and project management whose fixed term contract expired on 31 December 2011;
- one employee in President's office whose fixed term contract expired.

One employee changed her employment position from President's office to Education Unit, due to the fact that the position of an Administrative Assistant in the President's office was no longer needed and she had all qualifications for the Administrative Assistant in the Education Unit, who was very much needed. Her contract was extended for an indefinite period.

EMUNI University managed workload pressure with the help of the trainees and interns coming from various countries of the Euro-Mediterranean area, usually for a period of 3 months each.

Professors lecturing during the EMS modules held at EMUNI University were hired on the authorial contract basis.

7.1.9 Professional School: Euro-Mediterranean Studies 2012

The main aim of the module Euro-Mediterranean Studies (EMS) is to provide participants with a broad understanding of the Euro-Mediterranean region from different perspectives (economical, social, political, cultural, environmental, etc). The module was delivered in three terms at the EMUNI University's seat in Slovenia in three terms between February and May 2012, and in three different languages, English, French and Spanish:

7.1.13 INPDAP

7.2 Research & development activity and dissemination

EMUNI University is *per se* committed to contribute to research & development programmes and activities. Thus it is involved in many international projects and partnerships which enable EMUNI and other partners fostering and contributing to development of higher education.

EMUNI is partner organisation in several international projects:

1. "EuroMed Migration III" is a 3-year international project together with 5 partner universities and international institutions.
2. "Hands-On ICT: Learn, practice, teach creativity and ICT" (HANDSON) is a 3-year international project together with 5 partner universities and international institutions.
3. "ACP-EU Co-operation Programme in Higher Education" (EDULINK II) is 2,5-year international project together with 4 international organizations and universities from EU and Africa.

Apart from the above mentioned projects EMUNI University cooperated in several international programmes and events, applying and proposing projects with particular partner universities. The following activities are mentioned below:

Erasmus Partnership agreements

EMUNI University's network is confirming its commitment in broader regional and international cooperation in the field of education. As of December 2012 EMUNI had 109 bilateral agreements with different universities and institutions across the Europe and broader. Several Erasmus bilateral agreements were signed with the European Union countries and have enabled direct cooperation in the field of mobility for students, staff and professors. In 2012, EMUNI signed 2 bilateral agreements.

The main projects that were approved belong to different Slovenian, EU and international funding structures:

- EC – ERASMUS staff teaching mobility was signed with the Spanish partner (University of Murcia) for one EMUNI high education teacher.
- EC – ERASMUS Erasmus staff training mobility was signed in 2012 with the Spanish partner (University of Murcia) for one EMUNI staff person.
- EC – ERASMUS training programme was signed in 2012 with one person from the Italian University (Università degli Studi di Catania).
- EC – ERASMUS training programme was signed in 2012 with one person from the Italian University (Università degli Studi di Bergamo).
- EC – ERASMUS training programme was signed in 2012 with two persons from the Slovak partner University (Paneurópska Vysoká Škola).
- EC – ERASMUS study programme was signed in 2011 and carried out in 2012 for Euro-Mediterranean Studies with the Bulgarian partner Sofia University.
- LLP ERASMUS Intensive Programmes (IP) was signed in 2011 for a 3-year project titled “Intensive Programme Euro-Mediterranean Studies” together with 5 partner universities.
- ENPI Project with different subprojects was a two year pilot project signed between the European Commission and EMUNI University in 2009. In 2011 the project was extended for a further year, i.e. until 31 December 2012 due to some time constraints in the programme development. The activities of the project are in the ongoing phase and will finish at the end of 2012 (see item 7.2.1).

Erasmus Mundus

EMUNI University also acted as a partner in several Erasmus Mundus projects submitted and one was approved. EMUNI is supporting the Erasmus Mundus projects as a promoter by disseminating and publishing results.

7.2.1 EMUNI ENPI Project

ENPI Project is one of the most important projects for EMUNI. The project is financed through the European Commission and is lead by the project leader Prof. Dr. Nehale Fariid Mostapha, an Egyptian expert working at the Beirut Arab University in Lebanon.

The main focus areas of the project are:

- development of new EMUNI postgraduate study programmes in the field of the Union for the Mediterranean, which are planned to be implemented in 2013/2014 and later;
- development and preparation of the policies for the EMUNI Observatory for the important areas of HE, such as master and doctoral study programmes, quality assurance and e-learning;
- Dissemination of project achievements through different education and research activities, mainly through EMUNI conferences, regional days and publications.

With the ENPI Project EMUNI University established an excellent network of specialised study programmes among the universities in the Euro-Mediterranean region. The study programmes intend to be internationally comparable from the duration, credit points, and content and acquired scientific and professional titles points of view. It is planned that they will cover themes and fields which are important for the Euro-Mediterranean basin. The study programmes or parts of them will be set to be conducted in various universities, co-founders of the EMUNI University.

In 2012, the ENPI project ended. Contractual obligations were achieved and study programmes shaped. Due to legal procedures, EMUNI still has to fulfil some administration obligations. With regards to this fact, EMUNI expects to have minor delays. Reports for 2012 are currently in the submission process.

Also, EMUNI master programmes and PhD programmes developed in the frame of the ENPI Project were approved as UfM official projects. With the UfM label, EMUNI also started to look for national and corporate financing to fulfil its academic and student obligations.

7.2.2 EMUNI Conferences and other events

EMUNI conferences offer a valuable platform for the participants to network, exchange their expertise and gain additional knowledge on the selected topics. They are also aimed at disseminating research results.

ReSouk 2012

EMUNI Research Souk is an annual EMUNI conference, organized since 2009. The aim of the conference is to enable students to showcase and discuss their work in the field of research of topics in relation to Euro-Mediterranean issues also outside their host institutions and countries, as well as provide networking possibilities and exchange of experience in the international environment.

The 4th EMUNI Research Souk Conference was held from 17 to 18 April 2012. It was for the first time that the ReSouk conference was broadcasted from 15 different locations across the Euro-Mediterranean Area including different universities and other education institutions. Themes of conference were related to mobility of people and ideas, North-South and South-South cooperation and emphasising the education as a basis for job opportunities.

Co-organisation of Conferences

Apart from several international conferences that EMUNI has organized throughout the year, the university was invited to co-organize several events in cooperation with organizations, institutes and other universities. With a large network and good cooperation with partner countries EMUNI University is able to contribute with its network of experts which gives an added value to all kinds of events. Other conferences include:

Thematic discussions – round tables

Round table thematic discussions are prepared at EMUNI University at various occasions to increase the participation of professors, invited experts and students in the activities of EMUNI and introduce them to specific Euro-Mediterranean issues.

In May 2012, a round table 'Challenges and Future Prospects of Migration in EuroMed Area' was organized in Portorož in the frame of Spanish module of EuroMed Studies. The panel gathered prominent scholars and politicians along with EMS students from all across the globe.

EMUNI Regional Days

EMUNI Regional Days are a series of events, intended to introduce EMUNI to the EMUNI members, students and other interested participants in selected countries and regions. They involve lectures of EMUNI members and invited experts and a presentation of EMUNI through different publications and other activities.

In 2012 three EMUNI regional days were implemented at the following institutions: University of Zagreb (Croatia), University of Struga (FYROM) and the Iliria Royal University in Priština (Kosovo). EMUNI Days contributed to the introduction of EMUNI to the EMUNI members, students and other interested participants in selected countries and regions. They involved lectures of EMUNI members and invited experts and presentations of EMUNI through different publications and other activities.

EMUNI Talks

EMUNI Talks are series of events, organized by the EMUNI Foundation that feature prominent figures from the diplomacy, culture and politics. In 2011/2012 the 5th, 6th and the 7th EMUNI Talks lectures were held on following topics:

- Contemporary Arab Literature as a Reflection of Political and Social Changes (Ljubljana);
- Role of Young People in the Arab World (Ljubljana);
- Mental Revolutions and the Revolution of Mentalities (Ljubljana).

7.3 International activity and PR activities

Public relations (PR) are an important factor of international recognisability. EMUNI University communicates by regularly providing information about events and through the inclusion of public in the activities of EMUNI University (round tables, EMUNI talks, press conferences, etc.). The public relations are especially intensive at the time of execution of EMUNI projects, at the time of the meetings of the bodies of EMUNI University, at EMUNI anniversary and at the beginning of the academic year.

United Nation Alliance of Civilizations

EMUNI and the United Nations Alliance of Civilizations signed a cooperation agreement on 19 December 2008, sharing efforts aimed at strengthening intercultural dialogue, particularly in the fields of education and research. EMUNI is also a member of the AoC Research Network, launched at the AoC Forum in April 2009. Alliance of Civilizations acted as a co-organizer of the conferences EMUNI Research Souk 2009 and 2010. Moreover, in the summer 2010 EMUNI and AoC joined forces by the organisation of one of the summer schools in Portugal. Under the new leadership of HE Abdulaziz Al Nasser Al Attiah of Qatar, EMUNI is looking forward to work more closely with the UnoC most notably on issues that touch the south Mediterranean Countries in the Matter of Dialogue among Civilisations as stated in Doha Declaration of 2011.

The Anna Lindh Euro-Mediterranean Foundation for the Dialogue between Cultures

The Agreement on Cooperation with EMUNI was signed in Istanbul on 6 April 2009 with an aim to work together to develop innovative approaches to promote intercultural dialogue through the research and scientific cooperation activities. ALF worked closely with EMUNI on the organisation of the conferences EMUNI Research Souk 2009 and especially in 2010. EMUNI was also present at the Anna Lindh Forum 2010 in Barcelona from 4 to 7 March 2010.

Although cooperation has not reached the ambitions of both parties, EMUNI will continue to intensify its contacts with Anna Lindh and EMUNI University's new leadership is putting cooperation with this foundation as a top priority for EMUNI University in 2013.

EMUNI is involved in parliamentarian bodies of the Euro-Mediterranean, such as the **Euro-Mediterranean Parliamentary Assembly (EMPA)** and **Parliamentary Assembly of the Mediterranean (PAM)**.

EMPA - Working Group for EMUNI

EMPA - Working Group EMUNI is by the decision of the EMPA Bureau of 20 November (Cairo). On 28 November 2012 the Working Group for EMUNI held a session in Brussels. The new EMUNI management introduced new changes in EMUNI's development and the members exchanged views on the scope and priorities of EMUNI as well as on recent developments, and on the support granted to EMUNI by the European Commission.

15th CEI Dubrovnik Diplomatic Forum

For the second consecutive year EMUNI worked along with the Croatian Ministry of Foreign Affairs to organise the 15th CEI Dubrovnik Diplomatic Forum in May 2012. In the past few years the event has focused on relations with the Mediterranean, Russia and Eastern Partnership, including different aspects of regional and inter-regional co-operation, as well as pinpointing possible contributions in the fields of diplomacy and diplomatic training. The themes are also topical to the EU priorities and challenges, such as the regional and inter-regional aspects of

deepening and widening the EU policies, six axes of priority co-operation within the Union for the Mediterranean, Russia, EU and its neighbourhood etc.

The 2012 forum was run under the theme of Diplomatic training and intercultural dialogue and was marked by the establishment of the so-called "Euro-Mediterranean Association of Diplomatic Academies", in which EMUNI is foreseen to play a significant role in terms of providing pre-posting training for young diplomats.

7.4 ICT, technical support and information-communication affairs

The main tasks and goals of the IT department are determined by direct requirements of EMUNI University - to ensure operational state and high efficiency of computer-supported systems.

Support services are provided in different fields:

- maintenance and support of the computers and peripherals,
- communication technical services - maintaining the informational infrastructure,
- software solutions,
- office and enterprise systems,
- information security,
- graphical design.

Use of social media

In 2010 EMUNI entered the field of social networking by posting information on Facebook and Twitter, which is still being carried out on daily basis.

Facebook

EMUNI Facebook page acts as an addition to the existing EMUNI website. Most of the information that is available on EMUNI website is also available on the Facebook site. By doing so, the information is delivered to the members of the EMUNI Facebook site as soon as they are posted. Updates are being sent mainly through links or news feeds.

Google Apps for Education

As part of reducing IT costs and insuring better security and stability of the IT system, EMUNI University transferred some of the IT services to Google Apps cloud platform.

In 2010, EMUNI University started looking into systems that would offer staff a better and easier experience in using IT tools. Currently Google Apps are being used by staff only, but it has the option and potential to spread it into use with students, teachers and online classes.

Development of new website

EMUNI University is growing rapidly and with it its activities and services. Current EMUNI website was developed in the beginning of 2008 and had more of EMUNI to user informational purpose. Since web is changing rapidly and the role of user is not just reading information anymore, we believe that a new website with better information sharing, interoperability, user-centered design and collaboration of users is crucial for EMUNI. The development of the new website was not implemented in 2012 due to insufficient funding.

Development of Student Information Database System

The plan was to develop and deploy student information database system in 2012/2013 in order to support EMUNI's activities in running the study programmes. The system would be used to collect and manage student and staff information, analyze data, produce reports, generate correspondence and labels etc. The development of the Student Information Database System was not implemented in 2012 due to insufficient funding.

7.5 Research Publications

The IJEMS journal and conference proceedings represent an interdisciplinary contribution to the examination of topics which are relevant for the Euro-Mediterranean region.

International Journal of Euro-Mediterranean Studies

The *International Journal of Euro-Mediterranean Studies* (IJEMS) is a peer reviewed journal aimed at the promotion of intercultural dialogue and exchanges between societies, development of human resources, and assurance of greater mutual understanding in the broad crucial Euro-Mediterranean region. To accomplish this objective, the journal seeks to publish high quality research papers, scientific valuable articles, testimonies and case studies.

The key issues of papers include politics, sociology, economics, growth and development, human geography, environment, business and management, education, international relations, gender studies, life sciences and history.

So far, the topics have focused on civil protection, de-pollution of the Mediterranean, alternative energies, maritime and land highways, higher education and research, and business development in the Mediterranean. For this issue, we are looking for submissions from experts scholars from the broader field of the Euro-Mediterranean studies and related fields of interest.

As of 2012, the journal is published by the renowned publishing house Springer Verlag. The bodies and organs of the journal have been interrelated with two other Springer publications, *Journal Transition Studies Review*, scientific journal of the Transition Studies Network, based in Rome and Venice, and *Journal of Global Policy and Governance*, based in Rome, Venice and Udine universities, in partnership with the Institute of International Studies and the Center for Global Governance at the Fudan University in Shanghai, with a large network of Chinese and Asian universities.

The first issue since the Springer agreement was published in December 2012, including five articles with topics ranging from the geopolitical importance of the Euro-Mediterranean region, equity market risk during the economy crisis, corporate governance and Islamic finance markets. Two more issues will be published in 2013.

Conference proceeding

EMUNI published the Proceedings of 4th EMUNI Research Souk Conference in 2012.

Promotional publications in 2012 include:

8 ACCOUNTING INFORMATION FOR EMUNI UNIVERSITY FOR 2012

8.1 Main accounting principles

The Financial Report of the EMUNI University for 2011 has been drawn up in line with the Accounting Act (Official Gazette of the RS No. 23/99 30/02-ZJF-C and 114/06-ZUE) and the Slovenian Accounting Standard 36 - Accounting Solutions in Not-for-Profit Organisations - Private-Law Legal Entities (Official Gazette of the RS No. 118/05) and the Account Scheme for Not-for-Profit Organisations (Official Gazette of the RS No. 9/06).

When drawing up accounting statements the EMUNI University follows the following general principles of evaluation:

- Principle of continuity;
- Principle of consistency and
- Principle of timeliness.

The accounting statements and notes reflect the true and fair situation of operations.

8.2 Balance Sheet - general rules

The Balance Sheet is drawn up for a financial year, which is equal to the calendar year. The Balance Sheet as of 31st December 2012 shall also contain a column with data from the Balance Sheet as of 31st December 2011.

When providing explanations on the balance sheet items EMUNI University takes into account the rules on the content, layout and format of the financial statements.

Assets and liabilities are broken down per type and maturity.

Intangible and tangible fixed assets

The types of intangible fixed assets are defined in line with SAS 2, while the types of tangible fixed assets pursuant to SAS 1. They are measured in line with the SAS an initially recognised at their procurement cost. The procurement cost is composed of the purchasing price, the import and non-reimbursable duties and the costs of set-up for destined use. Any commercial or other discounts are subtracted from the purchasing price.

The residual value of intangible long-term assets and tangible fixed assets pursuant to SAS 1.17 and SAS 2.20 is disclosed in the Balance Sheet as the difference between the procurement value and the accrued correction of the value. The procurement value and the accrued corrections of value for tangible fixed assets and intangible long-term assets are disclosed separately in the accounting statements.

The depreciation of tangible fixed assets and intangible long-term assets is calculated individually on a regular basis by using the proportional method, consistently applied in each accounting period. The annual depreciation rates are set freely by the University. The net carrying amount of an item of tangible fixed assets is the difference between the cost of the item and its accumulated depreciation.

Tangible fixed assets, whose individual procurement value, as per the supplier's invoice, does not exceed EUR 500, are disclosed among small tools.

Individual items in the small-tools category, whose procurement value does not exceed EUR 500, are categorised as materials.

The EMUNI University had no long-term operating receivables in 2012.

Inventories

There were no inventories in 2012 at EMUNI University.

Short-term operating receivables

As of 31st December 2012, the University had 161,489 EUR worth of short-term operating receivables in the form of a deposit for a corporate credit card:

- no short-term receivables to the customers in Slovenia,
- short-term receivables to the customers abroad in the amount of 86,015.57 EUR,
- short-term receivables from the pre-granted advances in the amount of 2,417.26 EUR,
- short-term receivables to the Ministry of Education, Science, Culture and Sport (MESCS) from funding under the contract no. 3330-13-500019 for the month of December in the value of 27,885.95 EUR,
- long-term receivables to the physical persons in total of 39.077,39 EUR, predominantly addressed to the former EMUNI University president prof. dr. Joseph Mifsud.

Cash at hand

EMUNI University does not operate with cash, i.e. it does not cover costs of material by cash.

Cash at bank

The amount of cash in the current account, held at Nova KBM, amounted to 51.669,23 EUR on 31st December 2012.

Deferred costs and accrued revenues

As of 31st December 2012 the value of the deferred costs amounts to 14.369,66 EUR. The main part, i.e. 14.037,08 EUR is made of the principal and interest that EMUNI University has to return to CMEPIUS in the year 2013. A part of the funds in the amount of 6.868,13 EUR have already been returned to CMEPIUS due to the unfulfilled obligations from the agreement nr. 2010-7061-ERASMUS and were charged to the fiscal year 2012. The remaining part of the deferred costs at the value of 332.58 EUR comes from the deferred mobile phone costs and insurance premiums.

Short-term liabilities to employees

EMUNI University, founded on 13 February 2009, did not have employees in the year of 2009. The average number of employees on the basis of the working hours in the year 2010 was only 2 and 11.17 in the year 2011. On 31st December 2012 EMUNI University was obliged to the employees for the payment for the December salary and salary related costs and travel orders in the amount of 35,312.78 EUR. Liability arising from the travel orders predominantly arises from the former president's travel orders.

The average number of employees based on the working hours in 2012 was 7.8.

Short-term liabilities to suppliers

EMUNI University's short-term liabilities to suppliers on 31st December 2012 amount to 51,435.54 and consist of liabilities:

- to domestic suppliers in the amount of 40,021.10 EUR and
- to foreign suppliers in the amount of 11,414.44 EUR.

Other short-term operating liabilities

The other short-term operating liabilities in the total amount of 15,944.45 EUR on 31st December 2012 include:

- liabilities from authorial and single-task work contracts in the amount of 1,065.00 EUR;
- liabilities to the country of the contractual obligations in the amount of 516.82 EUR;
- liabilities to CMEPIUS from the unfulfilled obligations of the agreement nr. 2010-7061-ERASMUS that fall due in the year 2013;
- overpayment from the European Commission in the amount of 325.55 EUR.

Long-term operating liabilities

EMUNI University did not have long-term operating liabilities in 2012.

Short-term and long-term financial liabilities

EMUNI University had short-term financial liabilities from loan agreements with EMUNI Foundation, namely:

- 27,000.00 EUR since December 2011,
- 50,000.00 EUR since September 2012,
- 116,000.00 EUR since December 2012,
- that is 193,000.00 EUR in principal and 1,017.73 EUR in interest.

Long-term financial liabilities

Also in 2012 EMUNI University did not have long-term financial liabilities.

Short-term accruals and deferred income

On 31st December 2012 EMUNI University had no short-term accruals or deferred income recorded.

Surplus of expenditures over revenues

In 2012, EMUNI University generated 15,440.14 EUR in surplus of expenditures over revenues. Along with the surplus of expenditures over revenues from the previous year in the amount of 53,742.00 EUR, the final surplus of expenditures over revenues amounts to 69,182.14 EUR on 31st December 2012.

8.3 Statement of revenues and expenditures - general rules

In determining the revenues and the expenditures of the accounting period, EMUNI University applied the accrual principle of accounting in line with the Slovenian Accounting Principles. Total revenues index 2012 on 2011 is 126, while total expenditure index amounts to 133. Both revenues and expenses were influenced by two large projects financing and payments; i.e. ENPI project and EMUNI/INPDAP scholarships. The index on the labour costs amounts to 93, which shows significant savings on staff costs, influenced by the Act on the Balancing of Public Financing, decreased 2012 budget and drop in staff numbers. The average staff number based on working hours in the accounting period decreased from 11.17 in 2012 to 7.8 in 2012. Costs for goods, material, represent 65% of the total cost structure, while labour costs represent 35% of the total expenditure.

8.3.2 Notes to the statement of revenues and expenditures

REVENUES

Operating revenues from the performance of activities of non-commercial public companies

In 2012, EMUNI University has received in total 651,816 EUR from the activities of non-commercial public companies, from the following sources:

- funds from the budget of RS (MESCS) in the amount of 382,844.79 EUR or 58.7% of total revenues,
- part of funds from EC-ENPI project in the amount of 30,640.17 oz. 4.7 % of total revenues,
- grants under the agreements / contracts in the amount of 220,339.63 EUR oz. 33.8 % of total revenues; the two main sources in this category are:
 - a) INPDAP: 186,400 EUR for EMUNI/INPDAP scholarships and
 - b) ICMPD: 9,117 EUR for the EuroMed Migration III project,
- from the sale of services and reimbursement of costs in the amount of 17,991.68 EUR EUR or 2,80% of total revenue, which is irrelevant in the structure of the 2012 revenues.

Revenues from financial activities

EMUNI University had 18.70 EUR of revenues from financial activities in 2012.

Other revenues

Other revenues amounted to 1.05 EUR in 2012.

EXPENDITURES

Costs of material

The EMUNI University had a total of 6,837.81 of costs of material or less than 1% of all costs, in particular for utility and maintenance (electricity, water, heating and waste disposal) and an irrelevant share of office stationery and specialised literature.

Costs of services

In 2012 the University had 420,791 EUR EUR of costs for the services or 63.7% of total costs as follows:

- cost of authorial and single-task contracts in the amount of 107,987.19 or 25.7%
- cost of scholarships and study programmes in the amount of 98,851.70 EUR or 23.5%

- services on the business missions (hotel services, transport services, parking, per diem allowances) in the amount of 54,757.26 EUR or 13%,
- cost of telephone and postal services in the amount of 17,675.05 EUR or 4.2 %
- cost of editing, translation of 12,543.60 EUR or 4 %
- cost of advertising and entertainment in the amount of 12,126.29 EUR or 2.9 %
- cost of intellectual services (IT, printing and auditing services) in the amount of 8,224.42 EUR or 2 %
- cost of accounting services in the amount of 7,200.00 EUR or 1.7 %
- rental costs of 4,358.34 EUR or less than 1%
- 26% of the cost of services represent the cost of other services such as training costs, meals and transportation to the work of employees, insurance premiums, costs of payment transactions and other costs.

Labour costs

Labour costs accounted to 231, 712.76 EUR and represent 35% of total costs. They consist of:

- salaries and other salary reimbursement in the amount of 198,950.27 EUR,
- social security contributions in the amount of 27,687.82 EUR,
- other costs of work in the amount of 5,074.67 EUR.

Other costs

EMUNI University had no other costs recorded in 2012.

Financial costs

EMUNI University had financial expenses in the amount of 1,030.11 EUR due to the default interests from short-term loans in the amount of 1,017.73 EUR and differences in negative exchange rates in reference to foreign suppliers in the amount of 12.38 EUR.

Other expenses

The major part in the structure of other expenses, i.e. 6,868.13 EUR, relate to the funds to be returned to CMEPIUS in line with the 2010 agreement. Other unusual expenses arise from the financial penalties and compensation in the amount of 36.27 EUR.

Surplus of expenditures over revenues

As seen in the Statement of revenues and expenditures the surplus of expenses over revenues achieved with the operation of EMUNI University in the year 2012 amounted to 15,440.14 EUR EUR. Along with the surplus of expenses from 2012, the final surplus of expenses revenues on 31st December 2012 amounts to 69,182.14 EUR.
